Dear Secretary Pernia:

We the undersigned Philippine business groups and foreign chambers are writing to request that NEDA recommend to President Duterte to certify as urgent the Public Service Act amendments bill in the 17th Congress.

We are very concerned that the bill has yet to be approved by the Senate. After passing the House on 3rd reading on September 8, 2017, a hearing was held in the Senate Committee on Public Services on February 15, 2018 and the bill was quickly reported out on March 19, 2018. Sponsorship speeches were made by Senator Poe and Senator Gatchalian on March 20, 2018.

Since then there has been no further legislative progress in the Senate, where this important measure is pending the period of interpellation and amendment and 2nd and 3rd reading votes.

Should there be major differences between the House version and the final Senate version, a bicameral conference committee would remain the final hurdle to resolve such differences before final votes of approval in the two chambers and subsequent enactment by the president.

We have continuously expressed our support for this bill in Congressional hearings and most recently in correspondence sent to Congressional leadership.

The 17th Congress is rapidly running out of time to complete major legislation. Session resumes from November 12 to December 14 and from January 14 to February 8, 2019, or only eight weeks of session.

Enactment of the PSA amendments bill will lead to more foreign investment in public services in the country. This should result in more competition and better quality and lower prices of public services in the future. The greatest beneficiary of the reform will be Philippine consumers.

The PSA amendments bill is also – along with the open access bill – among the major advanced legislative reforms that implement the third point of the president’s Socioeconomic Agenda to increase the competitiveness of the national economy and to reduce barriers to foreign investment. 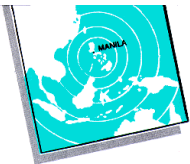
